The Court notes that the Seventh Circuit has clarified that IFP plaintiffs "have the same right as other plaintiffs to amend a timely filed complaint at least once as a matter of course . . ." and that even if "a timely complaint is dismissed but the action remains pending," the "amended complaint relates back to the filing of the original complaint" so long as the amended complaint asserts claims or defenses that arose out of the conduct alleged in the original complaint. Luevano v. Wal-Mart Stores, Inc., --- F.3d ---, No. 11-cv-1917, 2013 WL 3599156, at **5-6 (7th Cir. Jul. 16, 2013). Thus, so long as Plaintiff's claims were timely filed in connection with her original complaint (an analysis the Court does not undertake at this time), requiring Plaintiff to amend her complaint will not result in her claims being time-barred.
